**Treasurer's Report:** Teresa presented the Financial Report as of today. Treasurer's Report will be filed for audit as approved. Debbie Gilliard will receive the financials today as she has agreed to do the audit. Teresa presented the budget for 2017-18. Question arose regarding Candidates night expenses. Four groups will be co-sponsoring that event so not as much is needed from our chapter. Kay moved we adopt the budget as presented; Mary Ellen seconded. Budget adopted.

**State Meeting:** Cheryl reported on the State Planning meeting held at President Deb Fischer's home. State financials and budget were discussed. # BPW MEMBERS HAVE YOU SIGNED UP TO HELP WITH DECORATIONS, OR BEING A MODERATOR, OR BEING A TIMEKEEPER?

A Bit of History from Mary Ellen:

I'm excited to share something with you. First, I will give you information on my Grandparents, on my Father's side, gleaned from a book "House of Hanna." written in 1906, by Sarah A. Hanna:

**Robert Hanna** (born in 1744, in Virginia) was married to Mary Parks. Robert Hanna was a boyhood friend and college classmate of Thomas Jefferson. It is impossible to find out where he fits in my family tree because in some cases there are no dates listed and almost every family has a Robert. He was a General in the Revolutionary War. He could be a distant Grandfather or distant Uncle. Great Grandparents: David G. Hanna and Mary McKinney Great Grandparents: Catherine L. Hanna to John Cruikshank Grandparents: Bertha M. Cruickshank to Charles Lewis

#### Now, let's go to 1820:

Robert Hanna went to his bureau and taking therefrom a letter with a wax seal on it, he returned to his arm chair, saying, as he slowly unfolded the paper, "I have received another letter from my old friend, Thomas Jefferson. I wrote him some time ago, asking that the widows of Revolutionary solders might be pensioned." and then he read the letter:

### "Monticello, January 16, 1820

#### **General Robert Hanna**

"A letter from you, dear Sir, comes to me like one from the tombs of the dead. So long is it since I have had an evidence that you were still in the land of the living. So few are now so who were fellow laborers in the struggle for the liberation of our country. I rejoice to find that advancing years are the only assailants on your health mentioned in your letter. Times, well as ill health, bears heavily on me. Immediately on the receipt of your letter, I forwarded it to the President with the expression of interest I feel for your petition, and he will not be slow in giving his attention to Revolutionary mothers. I tender you my best wishes for the continuance of your life and health as long as you shall yourself wish them to continue." Th. Jefferson

After the letter was read, Robert Hanna has this to say: "We old soldiers considered the matter seriously that if our wives should linger longer here than we, they should have some recompense for their years of toil and privation endured in our terrible struggle for liberty and self-government, and as a result I forwarded their petition and I now feel assured that Jefferson will do everything possible to put the measure through."

Fac Simile Letter from Thomas Jefferson is in the book.. "House of Hanna." I checked the signature. According to the book, Thomas Jefferson was a boyhood friend of the Hannas and a classmate of Robert at Williams and Mary College. I also doubled checked the website and the above letter is on the website.
